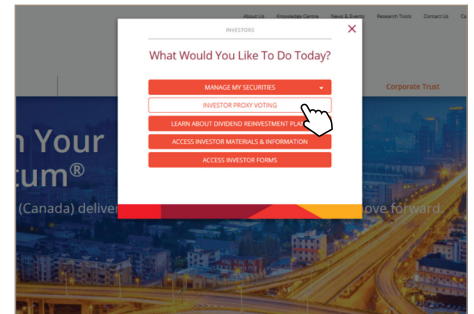
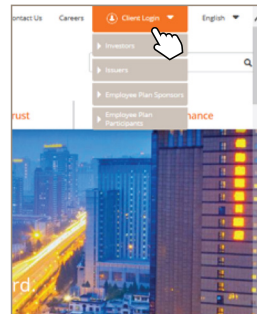


# WALKTHROUGH

The new experience is designed to reduce clicks, simplify wording, and create a more intuitive navigation structure when logging into AST portals, including allowing you to see all of your login options in one comprehensive, easy-to-follow view.

## Previous Experience

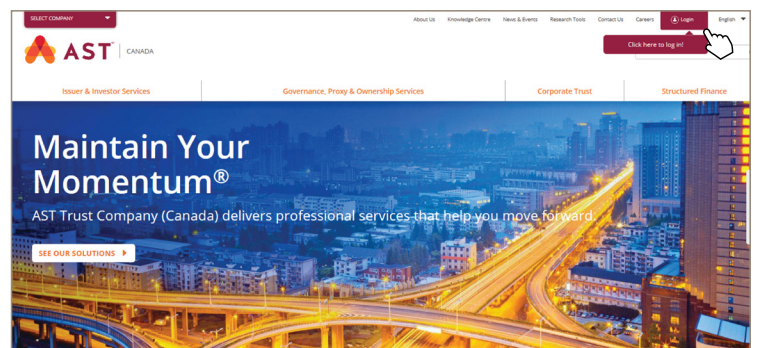
Previously, to navigate to your desired portal, you would click or hover on the Client Login button found in the upper-right corner of [astfinancial.com/ca](http://astfinancial.com/ca) and select your user type from the drop-down menu. This would activate a pop-up with multiple options. From there, you would click on the appropriate option to be directed to the corresponding login landing page. On the login landing page, you clicked on the Login button to navigate to the portal.



## Current Experience

We have simplified the login experience to a simple, 3-step process.
